Our Spring and Summer 2022 recruitment will be done in person and virtually through collaboration with our feeder middle schools. We will focus on at-risk populations that may not have college opportunities within the current 8th grade (upcoming 9th grade) class. The application process will be completed 100% online. Information sessions for the students and parents will be held to educate stakeholders on the requirements and benefits of enrolling in our Early College High School program. These information sessions will be held in both English and Spanish. Additional recruitment efforts will include shared ECHS testimonials as well as Question and Answer sessions from current students in the program. Regular communication, including application processes and deadlines, will be shared via campus, district, and program social media platforms (Facebook and Twitter) and our campus web pages.

High school counselors work with the IHE advisor, Fernando Acevedo, to set up whole group and individual advising sessions. Mr. Acevedo provides students with information including the college credits they are currently taking and the credits they have earned. He ensures that college credit is in the transcript and the transferability and applicability to the baccalaureate degree plan students are choosing to pursue. Mr. Acevedo also reviews the resources such as tutoring hours of the Palo Alto College Student Center, Library, Recreation Center, and the advising offices with the ECHS students.

John F. Kennedy Early College High School is responsible for all transportation costs and fees associated with program participation and acts as the responsible fiscal agent to provide all funds. Edgewood ISD's Advanced Academics Department collaborates with the Early College Campus and the Finance Department to create an ECHS budget based on program needs. If the MOU is terminated, then 11th and 12th-grade students enrolled in the ECHS program will continue to complete their coursework and continue to receive all supports associated with the Early College High School Blueprint to ensure both high school graduation requirements and IHE graduation requirements are met.

Mr. Acevedo, Palo Alto Advisor, communicates with the high school counselors weekly through zoom meetings and via email. He sends Early Alert Reports during the mid-term of each semester followed by a report before the last day to withdraw from a class. He shares concerns teachers share with him with the counselors. High School counselors then meet with students and families to give updates and find out what support students need. Mr. Acevedo provides final grades at the end of the semester, current college standings, and yearly audits for each student in the Early College High School program.

We continue to face challenges finding educators with the qualifications to teach dual credit classes due to teachers not having master's degrees with the correct 18+ hours discipline minimum. We work alongside Human Resources to review teacher qualifications to create a teacher recruiting pool for the Early College High School program. We also work with Palo Alto College to submit teacher transcripts for review of potential Dual Credit instructor candidates. We are working on creating professional learning teacher incentives such as planning days, ECHS professional learning community, and jobembedded professional learning.

College Pathways Courses	All students receive support by required enrollment in an advisory/college pathways class each year.
Individual Student Advising	IHE Advisor, Campus ECHS Director, and ECHS Counselor provide on-going, regular student advising.

ECHS student and faculty recruitment and retainment in accordance with the Early College High School Blueprint. John F. Kennedy Early College High School staff regularly collaborate with Edgewood ISD staff and Palo Alto College Staff to review ECHS implementation data to assess program progress.

Together we create in-time, targeted action plans to ensure ECHS program success and ECHS student success. We evaluate and analyze student progress toward college readiness via STAAR EOC results, TSI results, and on-going progress is current college courses to make recommendations within the program. We are focused on the successful attainment of outcome-based measures: 1. A minimum of 70% of ECHS students meet TSIA (TSI Assessment) College Readiness Standards in English Language Arts & Reading (ELAR) + Writing or TSI exemption through successful completion of first college reading/writing course (e.g., ENGL 1301/1302) by the end of 11th grade. 2. A minimum of 60% of ECHS students meet TSIA College Readiness Standards in math or TSI exemption through successful completion of their first college math course (e.g., MATH 1314 or higher) by the end of 11th grade. 3. A minimum of 30% of ECHS students achieve MEETS Grade Level on ENGLISH 2 EOC (during 9-11 grade.
